2022 Reunion --- Myrtle Beach, SC

We all missed not getting together for our Strauss 2020 and 2021 Reunions. COVID-19 is real and the cities just could not accommodate all of us as a group and meet the COVID-19 restrictions.

Bob and Leona Wilson and Bill and Vicki Smith are hosting the 2022 Reunion in Myrtle Beach, South Carolina. We have a contract with the Beach Cove Resort in North Myrtle Beach with an unbelievable room rate of \$108.64 per night including tax and resort fees, this would normally be in excess of \$200. The actual Reunion will run with check-in on Sunday September 18th and check-out Thursday morning September 22rd. We also have the same room rate guarantee for the three nights before the reunion (starting Thursday September 15th) and three nights after the reunion (ending with check-out on Sunday September 25th). So come for just the four day reunion or up to ten days of ocean front vacation. Each room has a kitchen and a balcony facing the ocean. We chose not to include breakfast in the room rate, but you can add that if you want to for \$10.95 per person per day. Check out this amazing resort and all they have to offer at www.beachcove.com

Reservations may be made by the individual guests making their own reservations by calling 1-888-974-5531 and refer to "USS Joseph Strauss Reunion". A first night's stay deposit is due at the time of making your reservation. All reservations must be made with the Beach Cove Resort by August 1, 2022. After this date, the reserved block of rooms will be released and reservations will be based on availability only and is subject to best rate available. The best rate available will be more than the group rate and will continuously increase as occupancy increases.

We will run this reunion a little different from the reunions in the past. We are not planning any daytime excursions to the surrounding areas. In your welcome bags will be maps, coupons and advertisements for local attractions that you can attend in smaller groups as we do not want to predict what the COVID-19 group sizes will allow local attractions to accommodate.

We are planning several meal opportunities so that we can have that wonderful time together that we so enjoy. The Beach Cove Resort has informed us that they can accommodate our group size with the current COVID-19 restrictions as they have allocated all of their banquet rooms to us instead of the1/2 to 2/3 that they would normally have given us.

Our planning to date includes a Welcome Reception with buffet and a cash bar outside around the pool (weather permitting) on Sunday night September 18th. We will work with Joanie Halfman and have an evening meal planned for Monday September 19th. Our Theme Dinner will be on Tuesday September 20st at the Beach Cove Resort, which will be followed by the auction. We will have our business meeting, Ladies Auction and the joint business meeting on

the morning of Wednesday September 21nd. Our Banquet will also be at the Beach Cove Resort on Wednesday evening September 21nd and that will be followed by the raffle. We will have an optional Farewell Breakfast on Thursday September 22rd before Check-out.

We were quite lucky to have found a place that really wants to honor the great veterans of this nation and have dedicated their facilities to us being able to hold our reunion even in the face of some COVID-19 restrictions. So come one, come all and pray for a vaccine that is effective and reliable, and then we can get back to something more normal even if we can't make it all the way back to full normal

2023 Mt Rushmore Reunion

Association Financial situation

Our treasury remains solvent with reserves in place to cover unplanned contingencies. The bulk of our finances are raised through our reunions from our raffles and auctions. Individual donations and dues provide the remaining funds. Without holding reunions our treasury funds have held steady as we have not published newsletters in 2021. For 2022 and beyond we will no longer publish a printed and mailed version. We plan to email the newsletter to those who provide us with their email address and we will post a version on our website. This change will result in roughly a \$1,200 cost avoidance to our treasury. And lastly, our Treasurer, Billy Joe, has developed an extensive financial accounting system to accurately and completely oversee our funds. Please review his report in the following paragraphs.

Treasurer's report – Amended 2022 update

Bill Cooper has been appointed interim Treasurer and has prepared an updated 6-year summary of our financial position.

- In accordance with the requirements of our By-laws an audit/review of our financials was conducted by the Officers and the chart below depicts our current financial state.
- The financial review included all transactions and accounts dating back to 2016.
- As part of the review, a Chart of Accounts was established and two primary Accounts were established, General Account and Reunion Account, to segregate income and expenses accordingly.
 - The General Account is for all income and expense line items needed to manage and sustain the Association regardless of whether we hold a reunion or not. Dues and donations are the primary sources of income for this account.
 - The Reunion Account is for all income and expense line items specifically related to holding a reunion.

As of 4/21/2022 all accounts have been reconciled and balanced and detailed exhibits have been provided to all Officers and Directors.

2021 – Year End, Officers & Directors Financial Summary

- We have a positive net income of \$1,679.69 for the year.
- We have received dues payments from 61 members, out of a roster of over 800 members, in 2021 totaling \$2,324.20 which is net of PayPal fees of \$20.36.
- We have also received donations of \$265.00.
- The only deposit we did not get returned for Portland is \$100.00 which has been written off as uncollectable.
- All obligations have been met and we have no outstanding items.
- In total, we have \$35,958.64 available and no encumbrances at this date.

2022 – 1st Quarter, Officers & Directors Financial Summary

- YTD 2022 we have received dues and donations from 2 members totaling \$120.00. See Dues Summary below.
- This is substantially behind where we were at this time last year.
- Our 2021 990 was filed on 04-07-2022
- In total, we have \$35,258.72 available and no encumbrances at this date. See Annual Consolidated Summary below.
- We have a negative net income of \$699.92 for the year.
- All financial disclosures are reconciled and balanced with asset accounts at Chase Bank and Paypal.
- Any Director or Officer wishing to review our Annual Financials can send me a request and I will send them a thumb drive with complete files.
